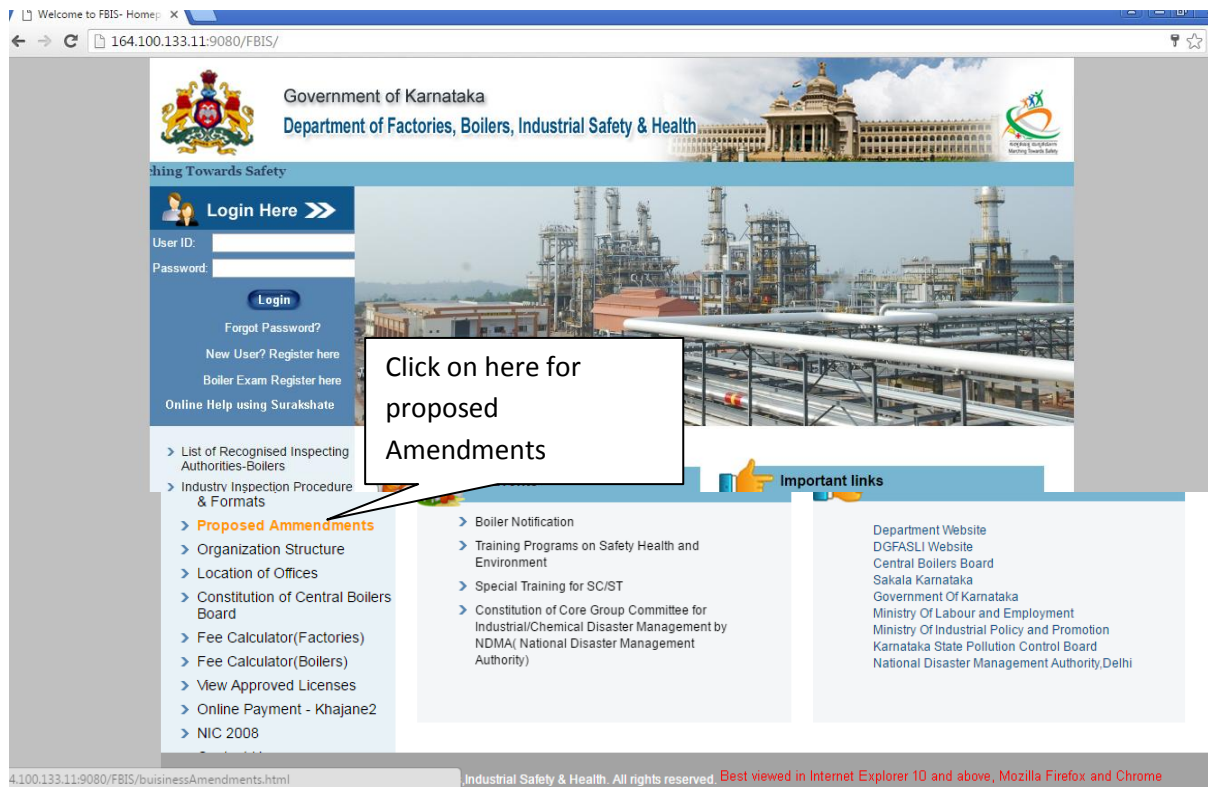

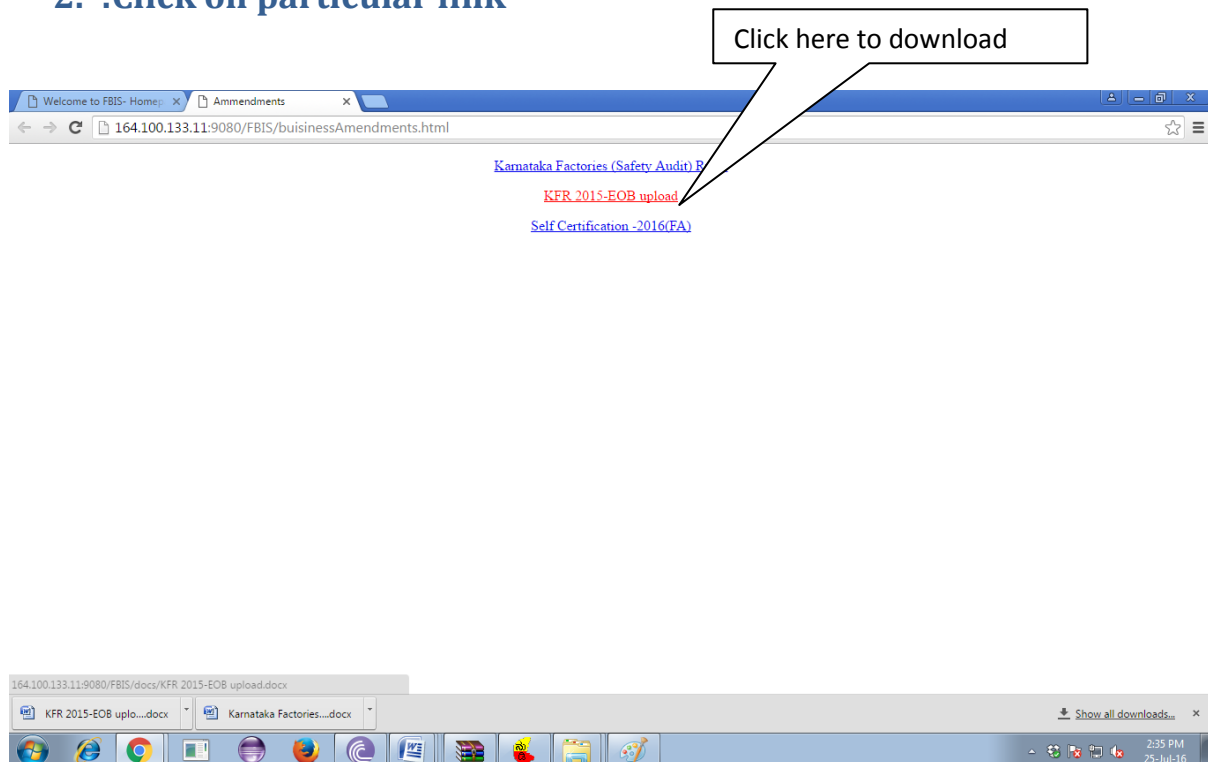

Karnataka Factories(Amendment) Rules 2015

In exercise of the powers conferred by clause (d) of sub-section 6, 41 of the Factories Act 1948 (LXIII of 1948), (Hereinafter referred to as the said Act) read with section 112 of the said Act, and of all other powers enabling it in that behalf, the Government of Karnataka hereby makes the following rules further to amend the Karnataka Factories Rules, 1969, the same having been previously published as required by section 115 of the said Act, namely:-

1. Short title, extent and commencement:-

- I. These Rules may be called the **Karnataka Factories(Amendment) Rules 2015**
- II. It shall extend to the whole of the State of Karnataka.
- III. It shall come into force on and from the date of its publication in the Official Gazette.

1. **Rule 3(2) shall be substituted as follows :** After the word **Form No. 1** in triplicate (Annexed to this amended rules) **or through online in Department website “e-surakshate”** shall be inserted.

the jurisdictional officer within 7 days of the date of inspection. And also such other informations as required by the chief inspector.

6. **Substution of Rule 4(1):** Application for Registration and grant of Licence: The occupier of every Factory shall submit, to the Chief Inspector / Jurisdiction officer an application in Form no-2 in triplicate, annexed to this amended rules with the list of Partners / Directors or through **online of the department web-site “e-surakshate”** for registration of factory and for grant of licence.
7. **Substitution for table-A & B of Rule 5(1):-**
Revised Fees specified in the annexed Table A and B.
After the worlds fees specified in the (Table A and B) **“annexed to this amended Rules”** shall be substituted.
8. **Rule 5(2):- In rule 5 sub – rule (2) - the words “three years” the words “Ten years” shall be substituted.**
9. **Rule 6(3):-** In Rule 6(3) after the worlds Licence shall be Rupees **“two fifty”** the words **“five hundred”** shall be substituted.
10. **Rule 7(2):** Every application for renewal shall be in Form 2 in triplicate or **online on the department web-site “e-surakshate”** and shall be made not less than two months before the date on which the licence expires.
11. **Rule 7(5):** Licensee may surrender his licence temporarily due to closure during the **ensuring year** not less than two months on which the licence expires, for claiming exemption from renewal of licence by post or through **online on the department web-**
