

Subject: Implementation of Business Reform Action Plan-2016

Sir,

In line with the initiatives of DIPP to enable Ease of Doing Business, Rajasthan has shown its commitment to simplify and rationalize the regulatory environment. Hon'ble Rajasthan High Court has constituted Commercial Appellate Division for Rajasthan High Court vide order dated 06.05.2016 and Law & Legal Affairs department, Government of Rajasthan has constituted 35 Commercial Courts in districts vide order dated 20.04.2016. For implementation of recommendation no- 334 (Merge payment of court fees and process fees into a single transaction/procedure) and recommendation no- 337 (Design and implement a system to allow for e-summons for commercial disputes in Commercial courts), the state has already made a request to hon'ble High Court Jaipur. The state requests for a neutral score on these points stating that further implementation of these points is not within the purview of the state government.
