

- (1) That, the occupier shall install single stage / multi stage wet scrubbing system depending upon the capacity (Number and Size) of ovens to achieve the required standard of particulate matters of 150 mg/Nm<sup>3</sup> in stack emission with the stack of height at least 30 m above the ground level.
- (2) That, the occupier shall ensure water used for scrubbing must be re-circulated and reused after proper settling and treatment and in no case it shall be discharged out of premises.
- (3) That, the occupier shall ensure that there shall be no leakage from the doors of the ovens and doors must remain sealed in order to minimize the fugitive emissions;


