
Exempt Green industries with a history of satisfactory compliance from environmental compliance inspection, or allow self-certification (in lieu of conducting physical inspections)

- 1 Agarbatties making unit
- 2 Air conditioners/ air coolers assembling unit
- 3 Bamboo/ Cane products (only dry process)
- 4 Book binding, Copy making, envelops, paper bags from paper/ paper board
- 5 Candles from wax
- 6 casting of Cement concrete grills
- 7 Computer software units
- 8 Cutting, polishing and finishing of stone marble/ granites
- 9 Electric iron/ heater/ domestic appliances assembling units
- 10 Electronics equipment assembling
- 11 Finishing of printed clothes by felt finish or rolled process, sintering
- 12 Flour Mill (Domestic Ata Chaki)
- 13 Fodders cutting machine
- 14 Footwear's/ bags making units frm Leather/ Rubber
- 15 Garments makinginy stitching/ tailoring from ready clothes
- 16 Glass frames for spectacles manufacturing
- 17 Iron doors and shutters fabricating unit
- 18 Jobbing and machining
- 19 Kitchen equipment/ cooker/stove assembling units (without electroplating and heat treatment)
- 20 Motor rewinding
- 21 Musical instrument making unit
- 22 Oil Ginning /Expeller unit (without hydrogenation/ refining)
- 23 Pickles/Papads making (upto 500kg per day)
- 24 Pump and motor assembling units
- 25 Radio assembling
- 26 Rice mullers (Domestic)
- 27 Scientific equipment, drawing and surveying fabrication unit
- 28 Sports gear making unit
- 29 Stationary items making units like paper pin, U-pin, pencils, etc.
- 30 Steel furniture fabrication unit (without electroplating)
- 31 Steel trunks/ suit cases making
- 32 Tablets and capsules amking units by mixing only
- 33 Toy making unit
- 34 Umbrella/ rain coats making units
