Factories Act, 1948. No. GHR/2016/42/FAC/142015/880192/M-3: The following draft of a notification which is proposed to be issued under clause (d) of sub-section (1) of section 6 read with section 112 of the Factories Act, 1948 (LXIII of 1948)(hereinafter refer to as "the said Act") is published as required by section 115 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration by the Government of Gujarat, after the expiry of a period of forty five days from the date of its publication in the Official Gazette.

Any objections or suggestions which may be received by the Principal Secretary to Government of Gujarat, Labour and Employment Department, Sachivalaya, Gandhinagar, from any person in respect to the said draft notification before the expiry of the aforesaid period will be considered by the Government.

Draft Notification

No. GHR/2016/42/FAC/142015/880192/M-3: In exercise of the power conferred by clause (d) of sub-section (1) of section (6), read with section 112 of the Factories Act, 1948 (LXIII of 1948), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Factories Rules, 1963, namely:-

- These rules may be called the Gujarat Factories Rules (Second Amendment) Rules, 2016.
- They shall come in force with immediate effect.
- 3. In the said rules, in rule 7, in second proviso to sub-rule (1), for the words "five consecutive years" the words "one year or any further period upto ten consecutive years" and, for the words "five times" the words "more than one year and multiplied by number of years" shall respectively be substituted.


