CIRCULAR:

Read: Business Reform Action Plan for States / UTs issued by Department of Industrial Policy & Promotion, Ministry of Commerce and Industry, Government of India.

- Department of Industrial Policy & Promotion, Ministry of Commerce & Industry, Government of India has prescribed Business Reform Action Plan, 2016 (BRAP-2016) for States/UTs, wherein it has been recommended to implement Single Window Clearance for establishment of new business under Ease of Doing Business (EODB) initiative. Evaluation under EODB initiative is a concurrent activity. During evaluation, DIPP will evaluate on investors feedback and experience of using online/offline single window system, current approval/ clearances process and grievance redressal mechanism undertaken at each level within the department.
- Under Business Reform Action Plan 2016: Sr. No: 1 titled "Access to Information and Transparency Enablers", the recommendations at serial number 12 and 13 are as under:
 - "Mandate and make arrangements to publish draft regulations online and invite public comments / feedback on the same prior to enactment;
 - 13. Manage and make arrangements to publish the comments/feedback received on the draft regulation and how they were addressed in the final regulation"
- Government has taken initiative and proactive approach in getting feedback/suggestions/comments from different stakeholders while making various polices. Since the polices are made by different Administrative

Departments, the government has decided that all the Administrative Departments should follow the recommendations under BRAP 2016 scrupulously, while making a policy or making amendments to an existing policy concerning trade and commerce, or industry or business.

- 4. The arrangements for receiving comments/feedback/suggestions by keeping the draft document in public domain prior to its notification should meet the recommendation for access by enablers to information and transparency under the Business Reform Action Plan – 2016.
- In view of the above, all Administrative Departments of the State Government are therefore, requested –
 - to ensure and make arrangements to publish draft of a proposed policy relating to business, industry, trade and commerce, online and invite public comments / feedback on the same prior to issuance;
 - to ensure and make arrangements to publish the comments/feedback received on the draft policy and how they were addressed in the final document which was published.






