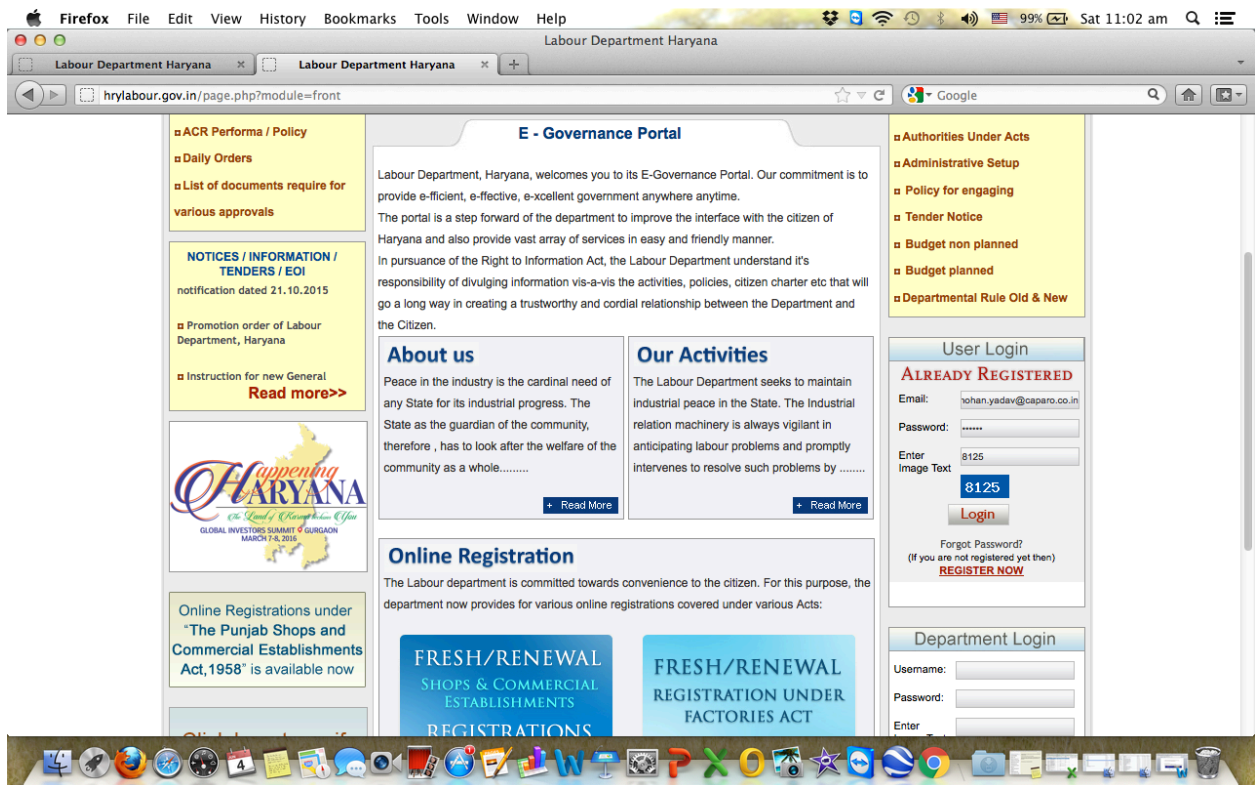
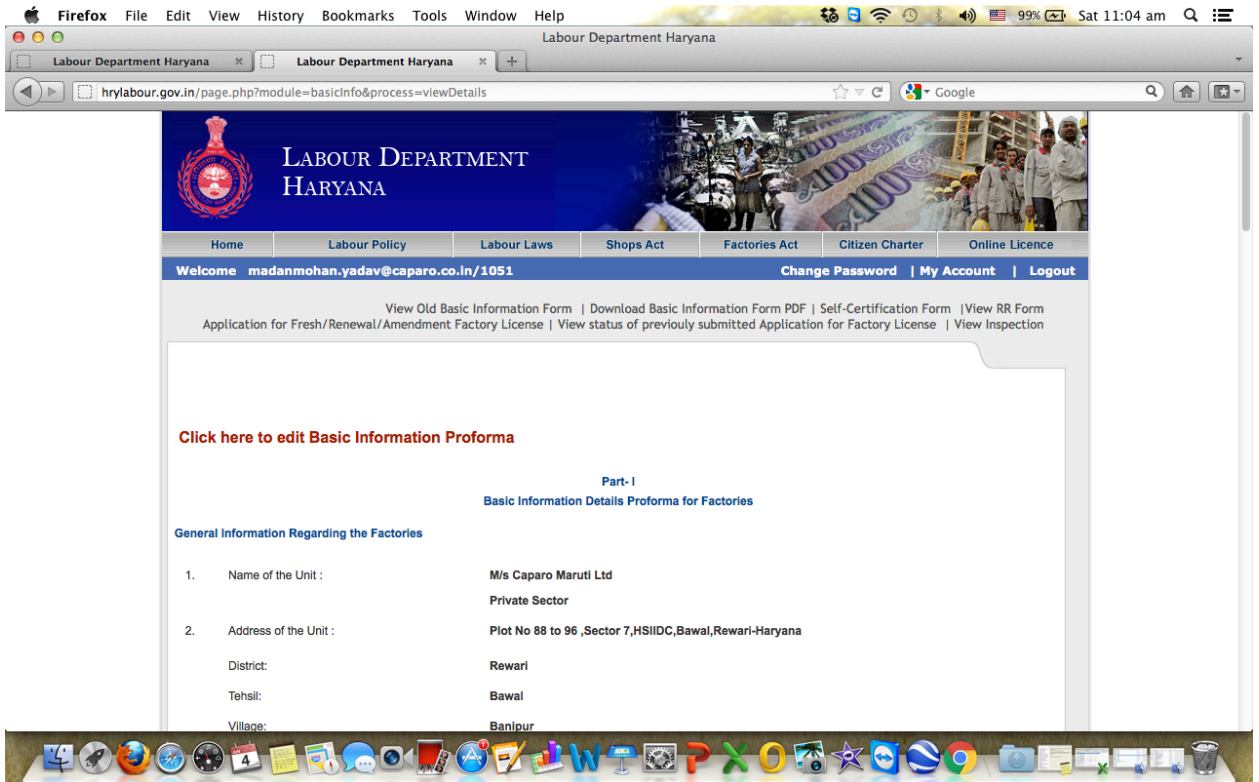

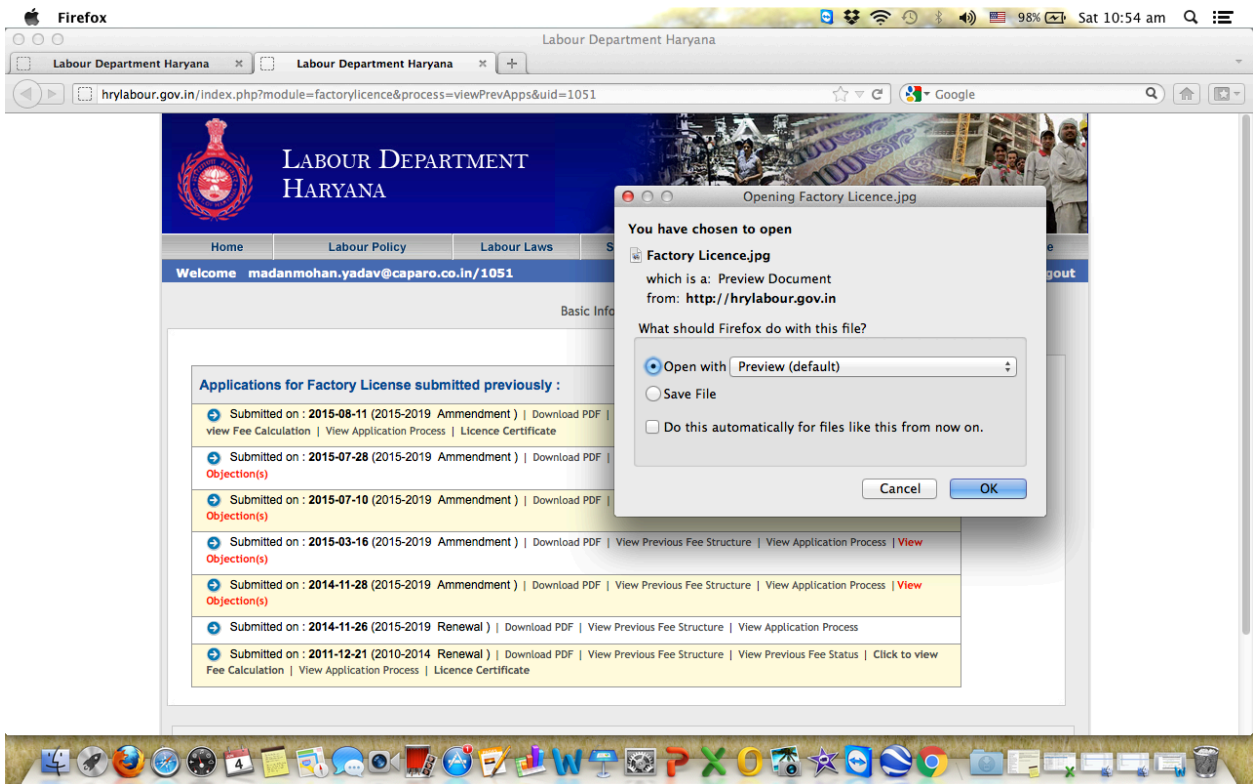
1. The applicant can download the final approved certificate once he login in his account

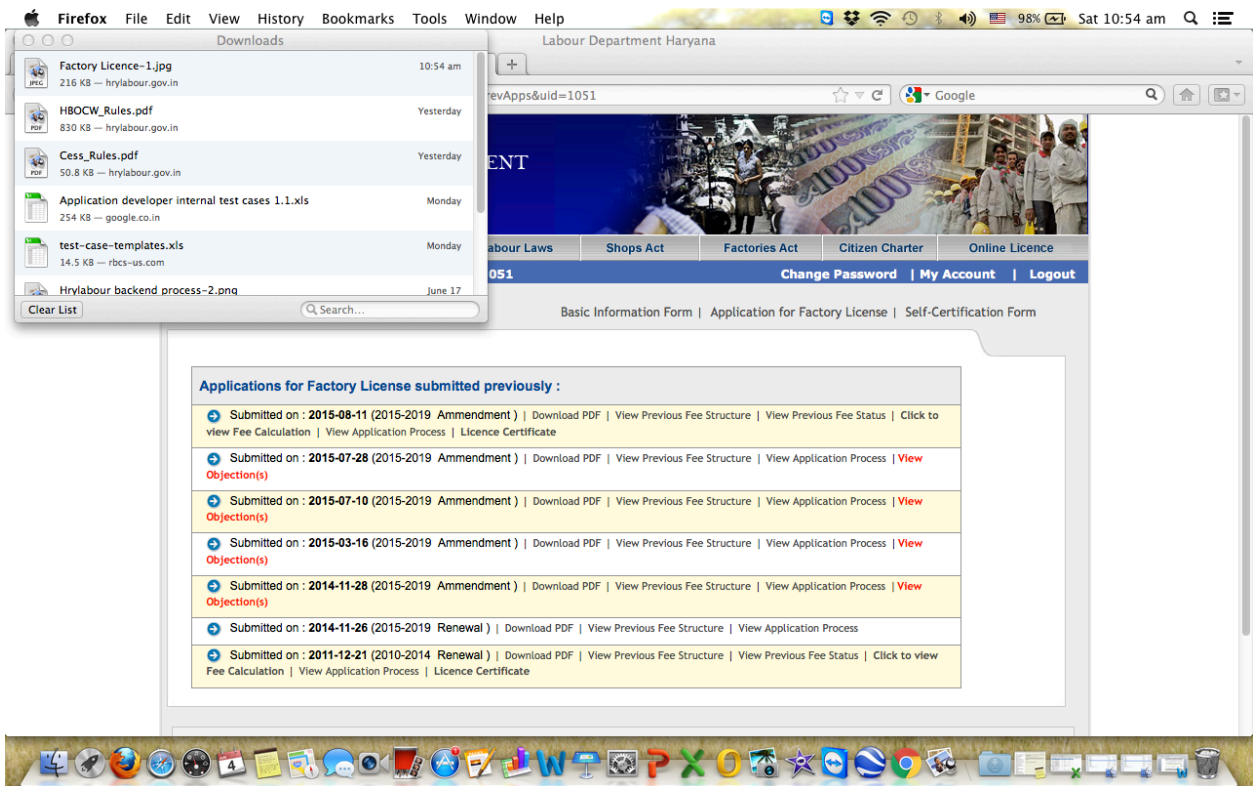


3. Once login the option appears to view the status of submitted applications and also an option to download the certificate.
