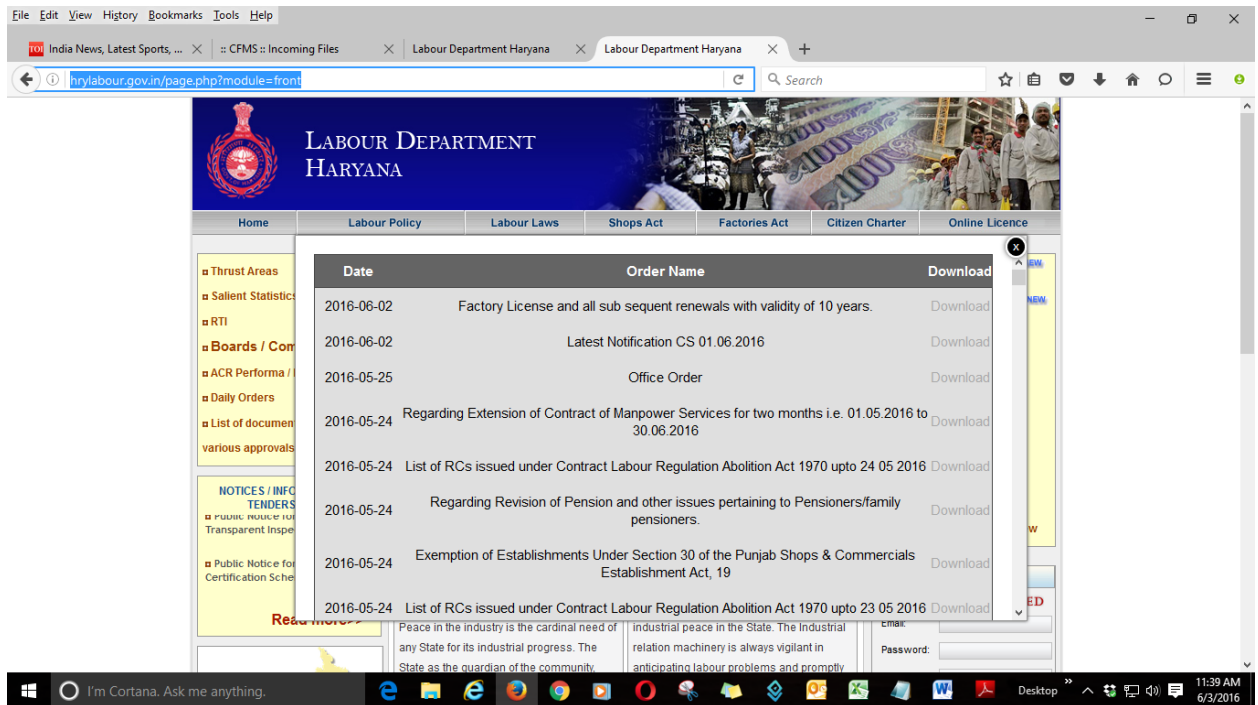

<ul style="list-style-type: none"> As per Section 12 of the Contract Labour (R&A) Act, a contractor executing any contract work by engaging 20 or more contract labourers has to obtain a licence under the Act. The term contractor includes a sub contractor. The Local District Labour Commissioners have been declared as Licensing Officers who will grant licenses to the contractors. The contractor has to apply in Form No. 4 in triplicate to the Licensing Officer along with Treasury Challan in support of deposit of security deposit and prescribed fee. 	<ul style="list-style-type: none"> Form No. 4 Form No. 5 	Fees Structure	26 days	NA
