C.2. Application and approval procedure

#	Process
2.	<u>Online Application</u> Register yourself on the website https://www.bihar.gov.in/service_lrd . If you are already registered on the portal then login with the registered user id and password.
4.	Upload all the relevant documents as per the above mentioned checklist and submit the form.
6.	<u>Manual Application</u> Fill in the prescribed application Form (Form No. 1 as per the Act.). Attach all the relevant documents as per the abovementioned checklist and submit the Form at the office of District Labour Office along with requisite application processing fees in form of Treasury Challan. Go to Step 7.
8.	<ul style="list-style-type: none"> • Next, filled application form will be scrutinized by the Labour Superintendent followed by a site visit if required. • In case there is any query the same would be communicated to the applicant and a suitable timeline would be given to answer the query. In case there is no query or the query is resolved within the stipulated time the application would be approved and permission would be granted. • In case the query is not answered within the stipulated timeline by the applicant the application

	would be summarily rejected.
