



This shall come into force with effect from the date of issuance of this notification.



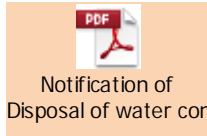
