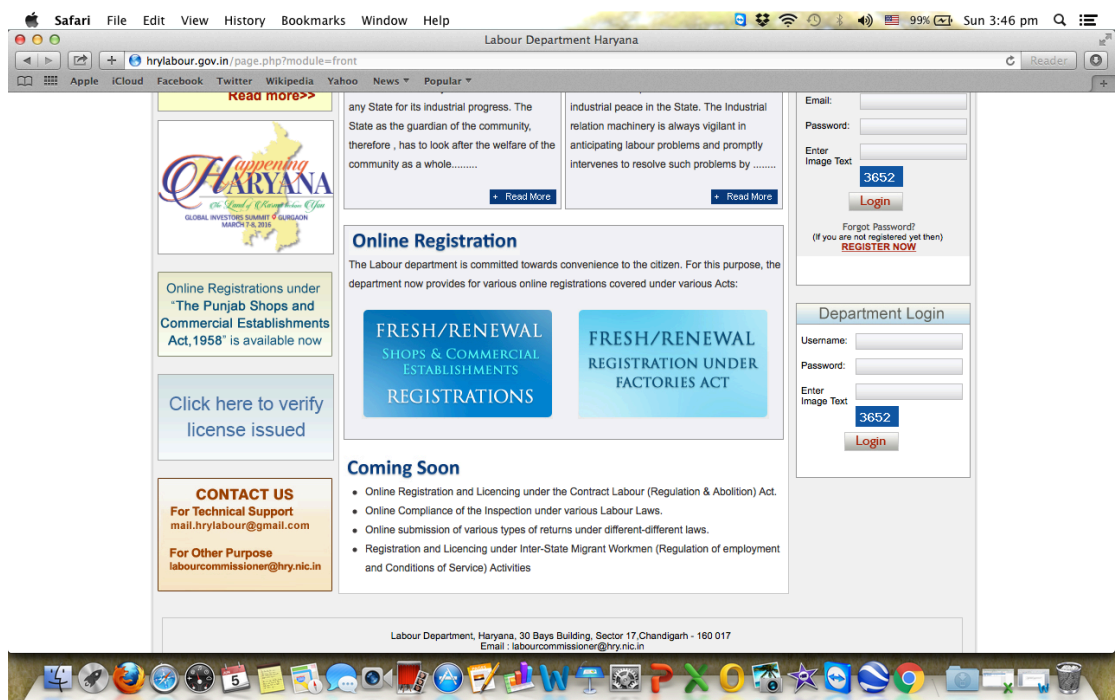
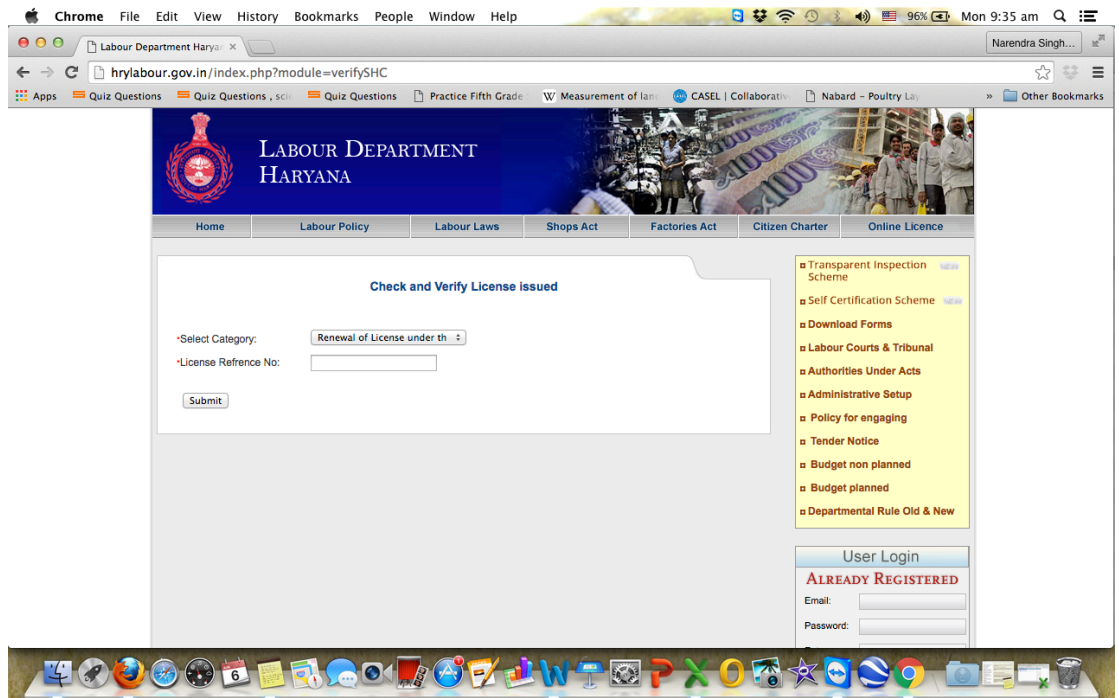

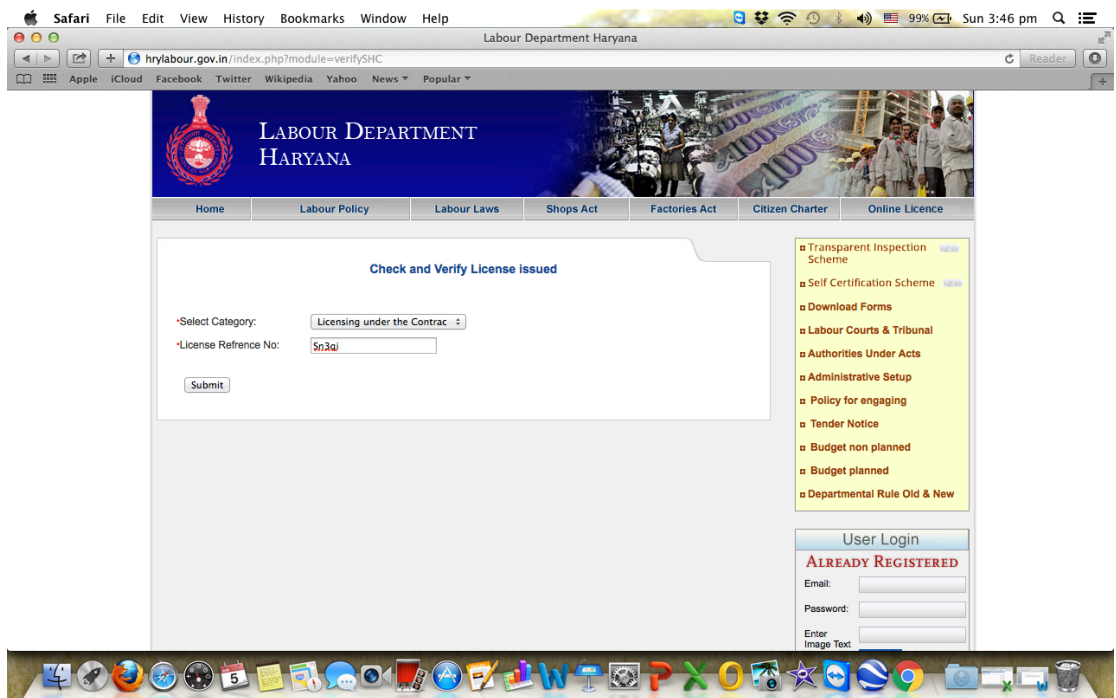
1. The service has been designed such that the user is allowed to download the final signed approval certificate from the online portal as shown in following screen shots. He is only required to use a unique reference number that is generated by the system at the time of submitting the application.
2. Firstly he has to come the departmental website at url hrylabour.gov.in and come to the option “ click here to verify license issued” at home page as shown in the below screen shot



3. Clicking on this icon take to the next user interface allowing to select the relevant service for downloading or verifying the license as shown in the screen shot



4. Then use the unique reference number generated at the time of submitting the applications to download the certificate as shown in the screen shot below

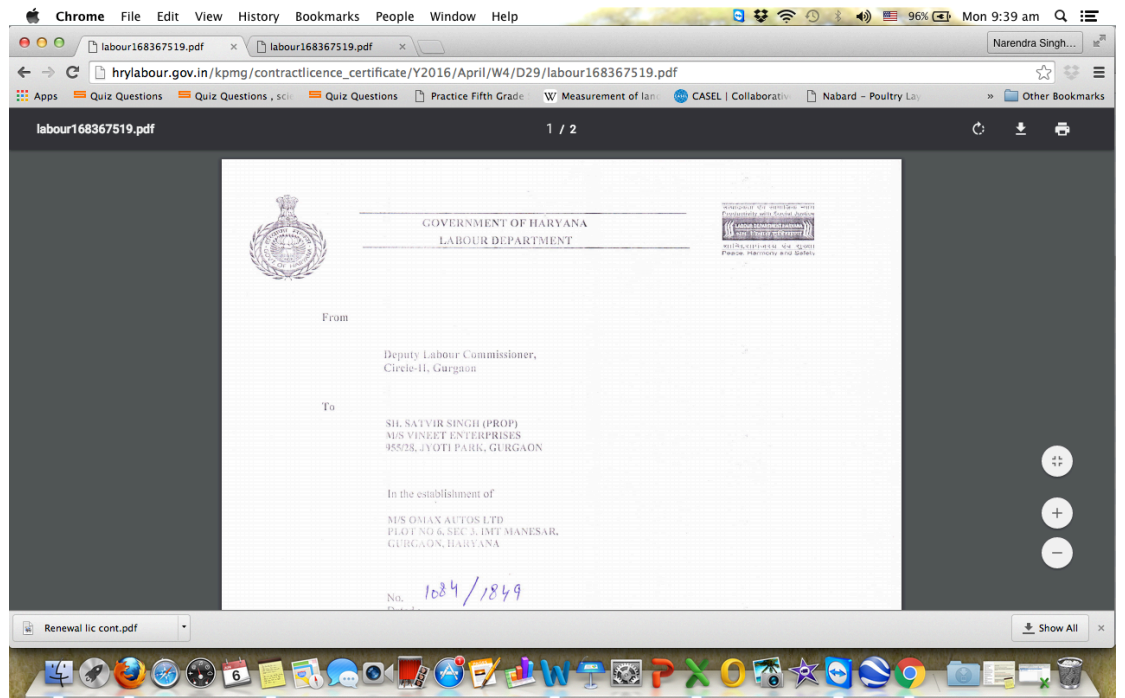

CONDITIONS OF THE LICENCE

The Licence is subject to following conditions

- The Licence shall be non-transferable.
- The number of workmen employed as contract labour in the establishment shall not, on any day exceed as given in the licence above.
- Except as provided in the rules the fees paid for the grant, or as the case may be, for renewal of the licence shall be non-refundable.
- The rates of wages payable to the workmen by the Contractor shall not be less than the rate prescribed for in the schedule of employment under Minimum Wages Act, 1948 where applicable and where the rates have been fixed by agreement, settlement or award not less than the rates fixed.
- In case where the workmen employed by the contractor perform the same kind of work the workmen directly employed by the principal employed by the establishment, the hours of worker and other conditions of service of the workmen of the contractor shall be same as applicable to the workmen directly employed by the principle of the establishment.
- In other cases the hours of work and conditions of service of the workmen of the contractor shall be such as may be specified in this behalf by the Labour Commissioner.
- In every establishment where 20 or more women are ordinarily employed as contract labour, there shall be provided 2 rooms of reasonable dimensions for the use of their children under the age of six years. One of such room would be used as the playroom for the children and other as bed room for children. For this purpose the contractor shall supply adequate number of toys and games in the playroom and sufficient number of cots and bedding in the sleeping room. The standard of construction and maintenance of creches may be such as may be specified in this behalf by the Labour Commissioner.
- The licensee shall intimate any change in the number of workmen or the conditions of work to the Licensing officer.
- The contractor will be available and accessible to the workers at the work site.
