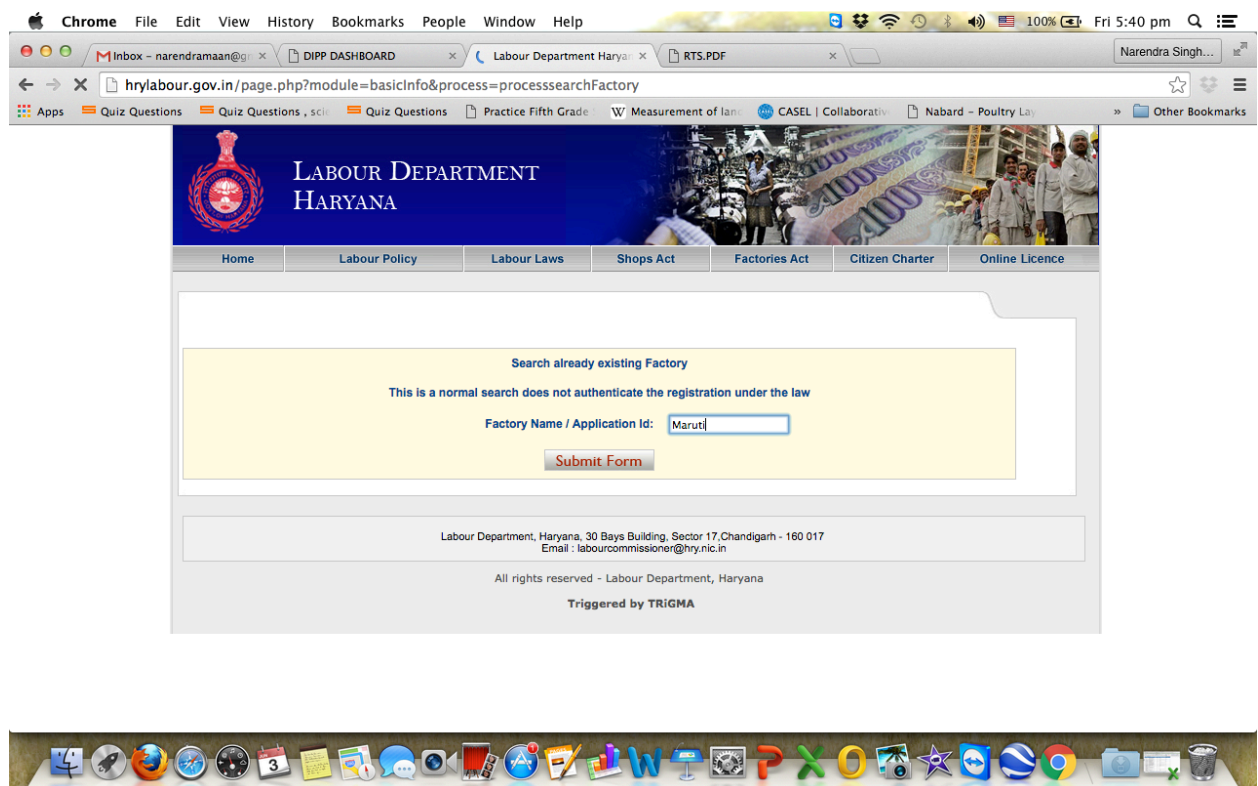

1. The service has been designed and implement in such way it allows online application, payment, tracking and monitoring without the need for a physical touch point for document submission and verification

3. For this service the user is to login at the department website using credential already created when came to website for the first time.
4. If he is not already user on the website and coming for the first time for renewal, if first certificate was obtained in offline mode prior of online mode introduction, then firstly applicant has to create their user profile that is called the Basic Information Performa in Form F as once in life time exercise. The first loop ensure for prevention of duplication of profile creation by enabling the user to search for their credentials as shown in the below screen shots.

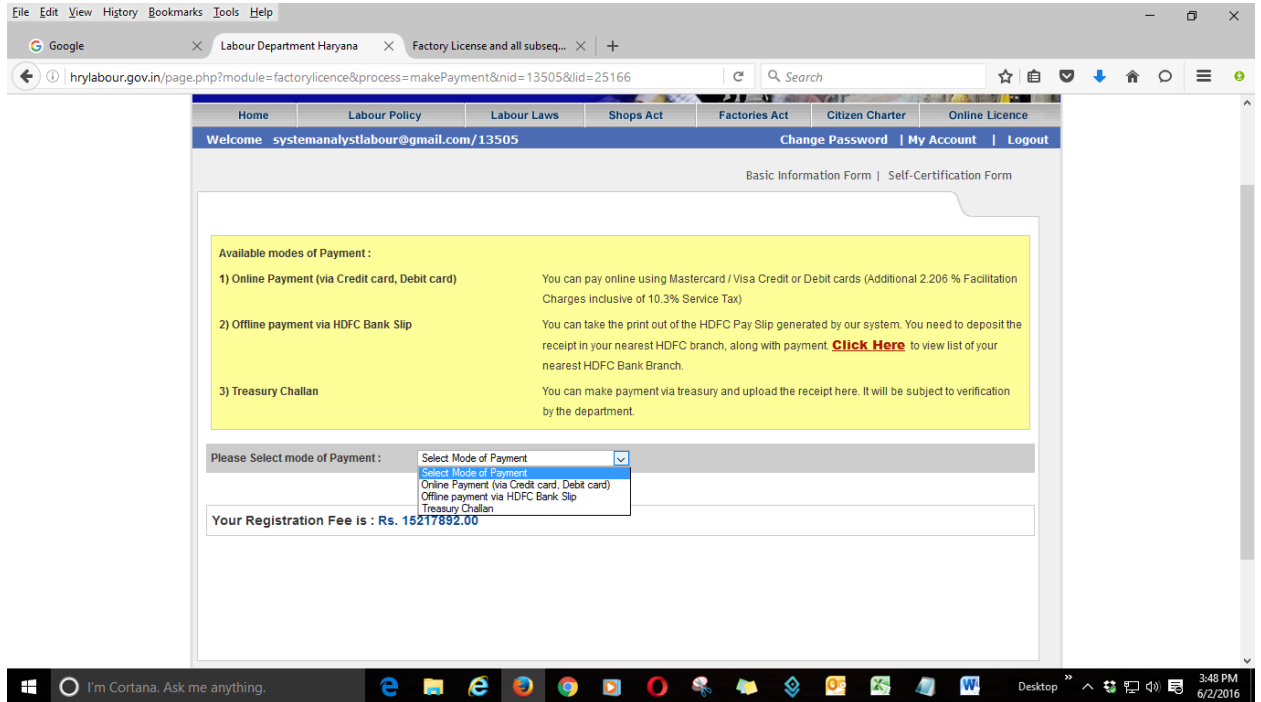

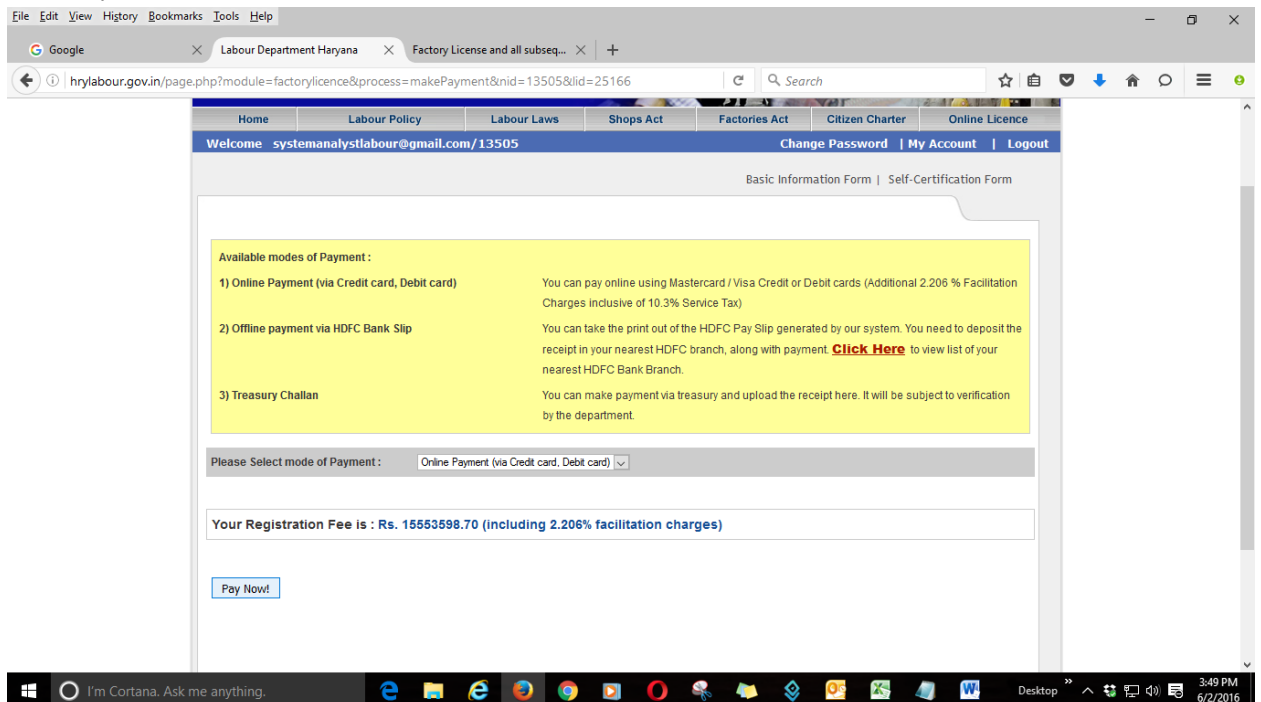

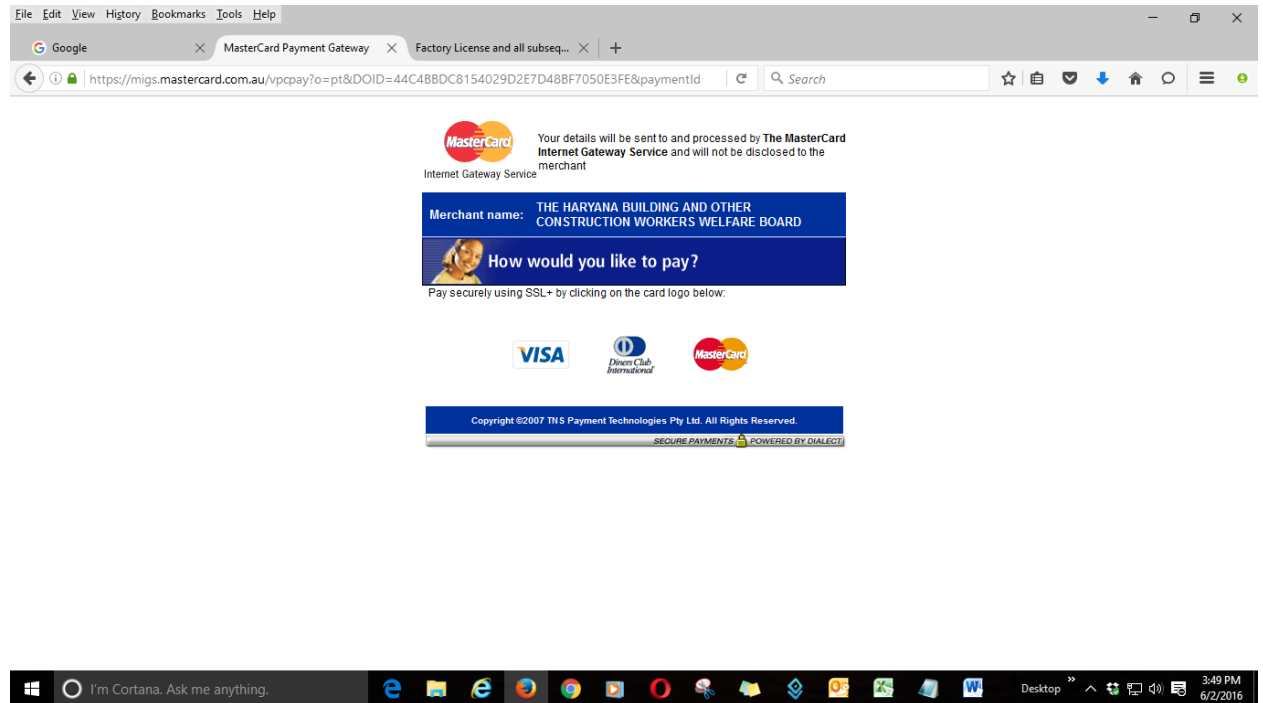
6. On Click on “click here to Pay” the payment gateway appear



7. Click Pay Now

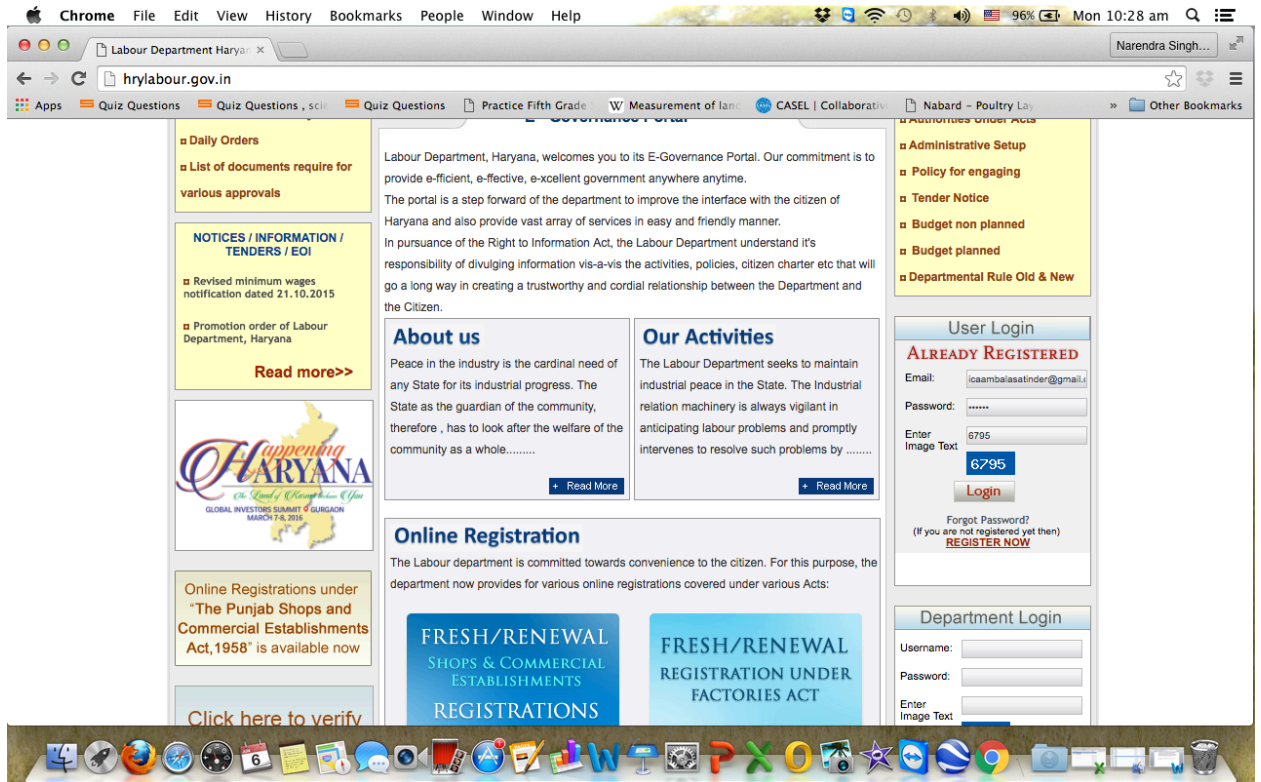


Select the card payment option

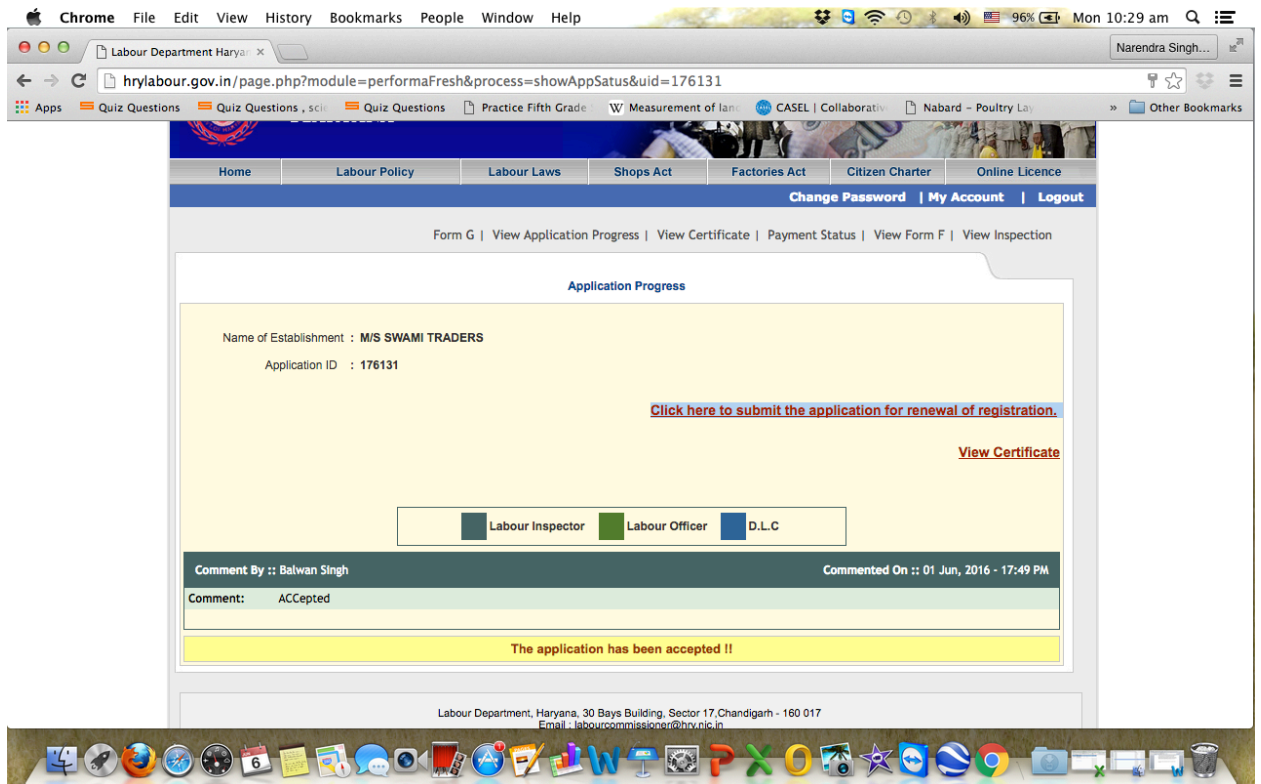


8. The departmental authorities process the applications. The registering officer i.e. Labour Inspector physically visit the area if required and verify the existence of the shop/establishment and grant the registration certificate on finding the applications and document proper.
9. In this process the applicants is not required to physically visit the office at any stage.
10. However if the user is already user at the website he simply login in with the user ID and password provided at the BIP profile creation and is not required to create fresh BIP. Once logged in, he only make the renewal application and step for at 6, 7 & 8 are similar for fee payment and he can track the application in the login with complete history in real time as shown in the screen shots given below:-

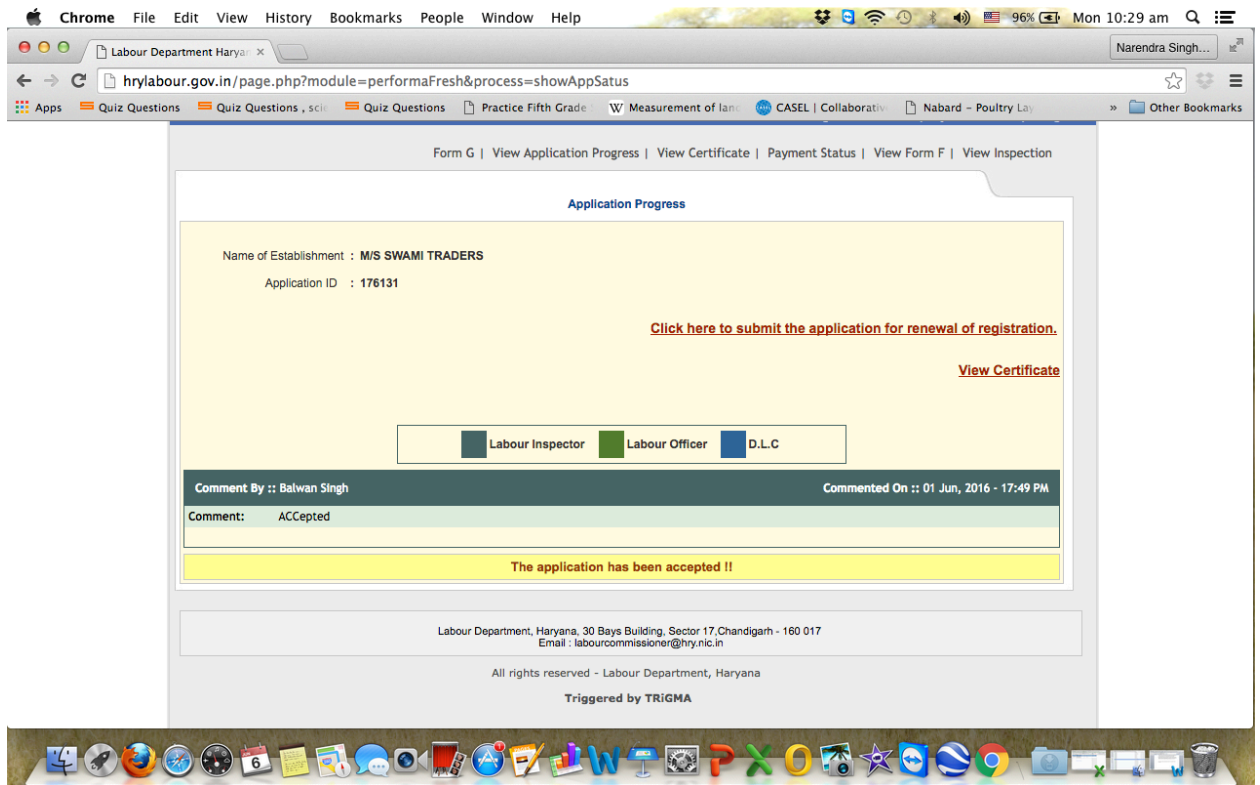
