It may then be filled up online or through XML upload. Once that is done, the acknowledgement number is generated and the dealer can download the PDF version of the permit</p>

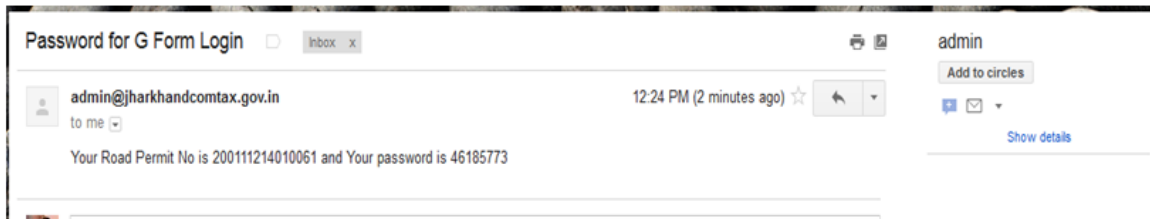
