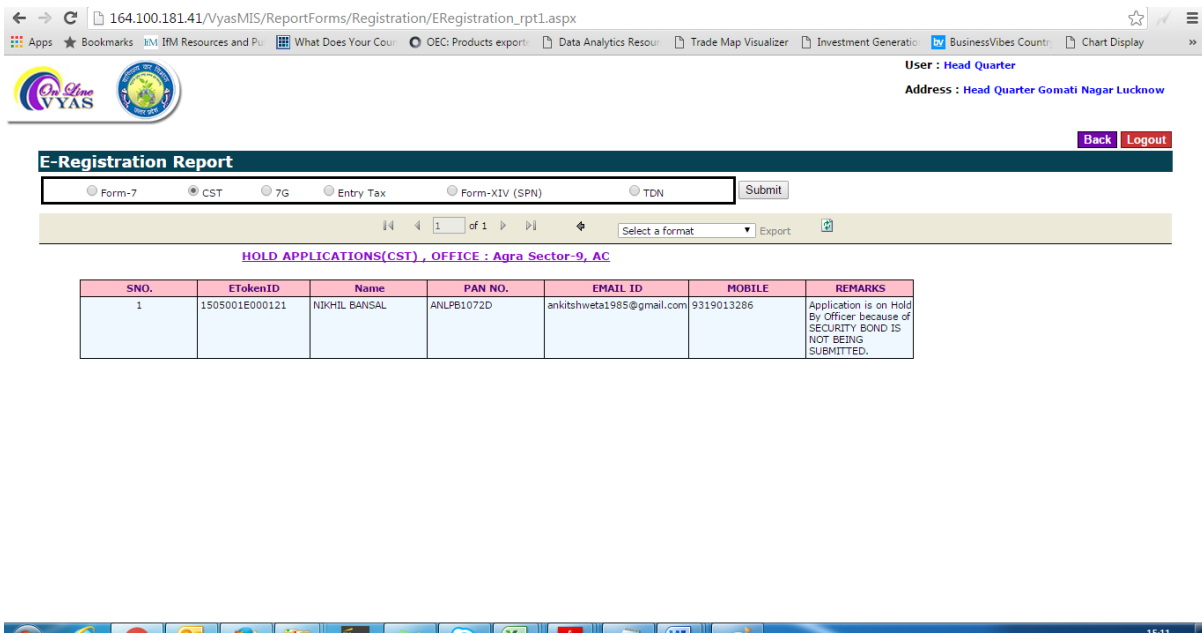


Fig.5 (CST MIS)

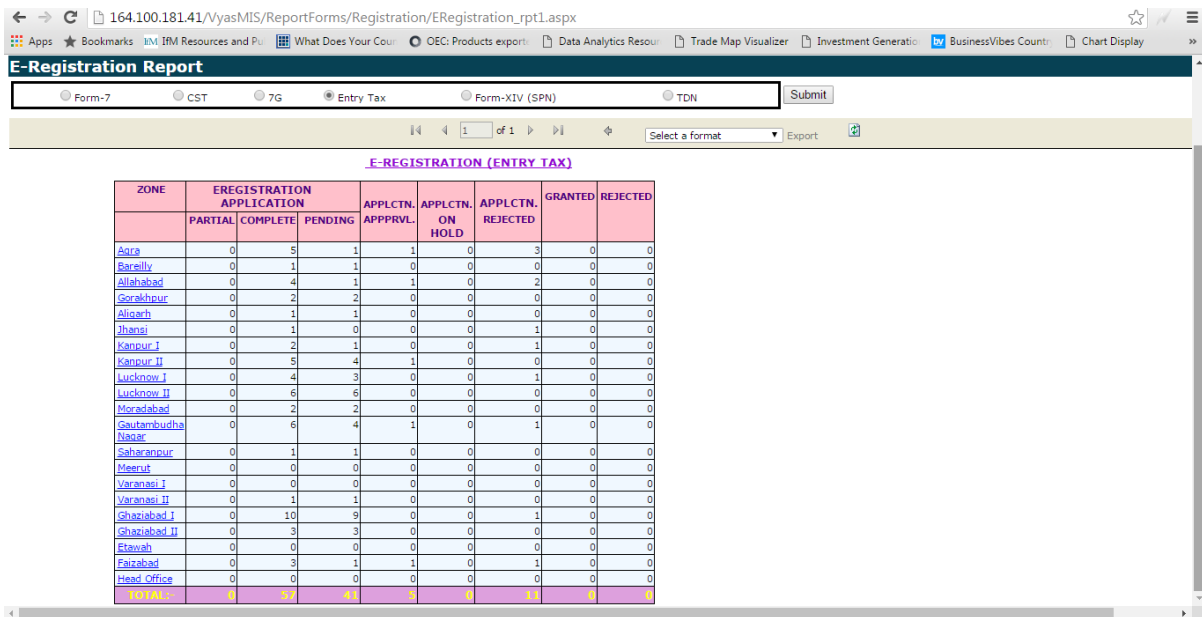


Fig.6 (Entry Tax MIS)
