- a. License to manufacture fireworks or gunpowder or both not exceeding 15 kilograms at any one time.
 - b. License to manufacture fireworks or gunpowder or both exceeding 15 kilograms but not exceeding 500 kilograms at any one time.
 - c. License to manufacture fireworks or gunpowder or both exceeding 500 kilograms at any one time.
 - d. License to manufacture at site, ANFO explosives not exceeding 200 kilograms at any one time.
 - e. License to manufacture liquid oxygen explosives (LOX).
 - f. License to manufacture site mixed explosives (SME)
 - g. Licence to manufacture explosives other than fireworks, gunpowder, ANFO, LOX and SME.
19. License under Article No. 2 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to possess gunpowder not exceeding 15 kilograms at any one time for manufacture of adirverttus and possession of adirverttus not exceeding 200 in number at any one time.
 20. License under Article No. 3 (Schedule IV, Part 1) of The Explosive Rules, 2008
 - a. Licence to possess for use, for agricultural purpose or in small quarry, explosives not exceeding 25 kilograms of Class 1 or 2 or 3 and 1500 numbers detonators; and 1500 meters of detonating fuse or safety fuse at any one time in a magazine.
 - b. Licence to possess for sale, explosives of Class 1, 2, 3, 4, 5, 6 or 7 in a magazine.
 - c. Licence to possess for use, explosives of Class 1, 2, 3, 4, 5, 6 or 7 in a magazine.
 - d. Licence to possess fireworks not exceeding 5000 kilograms or safety fuse not exceeding 50000 meters, in a storehouse, not for sale but for transfer to own licensed shop.
 21. License under Article No. 4 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to possess and transport explosives of class 2 or class 3 not exceeding 25 kilograms, electric or ordinary detonators not exceeding 200 numbers, detonating fuse not exceeding 100 metres and safety fuse not exceeding 200 metres in a compressor mounted motor truck or tractor for use in well sinking.
 22. License under Article No. 5 (Schedule IV, Part 1) of The Explosive Rules, 2008
 - a. Licence to possess and sell from a shop, at any one time, not exceeding 25 kilograms of small-arms nitro- compound
 - b. Licence to possess and sell from a shop, at any one time, not exceeding 100 kilograms of manufactured fireworks of Class 7, Division 2, sub-division 2; and 500 kilograms of Chinese crackers or sparklers
 - c. Licence to possess and sell from a shop, at any one time, not exceeding 2000 numbers of pyrotechnic device explosives of Class 6 Division 1
 - d. Licence to possess for use Gunpowder not exceeding 5 kilograms and safety fuse not exceeding 50 metres in the States of Bihar, West Bengal, Kerala and Tamil Nadu.
 - e. Licence to possess for use of small-arms nitro-compound not exceeding 5 kilograms in the State of Kerala.
 - f. Licence to possess and sell from a shop manufactured fireworks of Class 7 Division 2 sub-division 2 exceeding 100 kilograms but not exceeding 300 kilograms, and Chinese crackers or sparklers exceeding 500 kilograms but not exceeding 1200 kilograms.
 23. License under Article No. 6 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to possess and use fireworks for public display.
 24. License under Article No. 7 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to transport explosives in a road van.
 25. License under Article No. 8 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to import or export explosives otherwise than by land.
 26. License under Article No. 9 (Schedule IV, Part 1) of The Explosive Rules, 2008 - Licence to manufacture, possess, sell, use, etc. of explosives not provided in articles 1 to 8. License for Operation of Cold Storage
