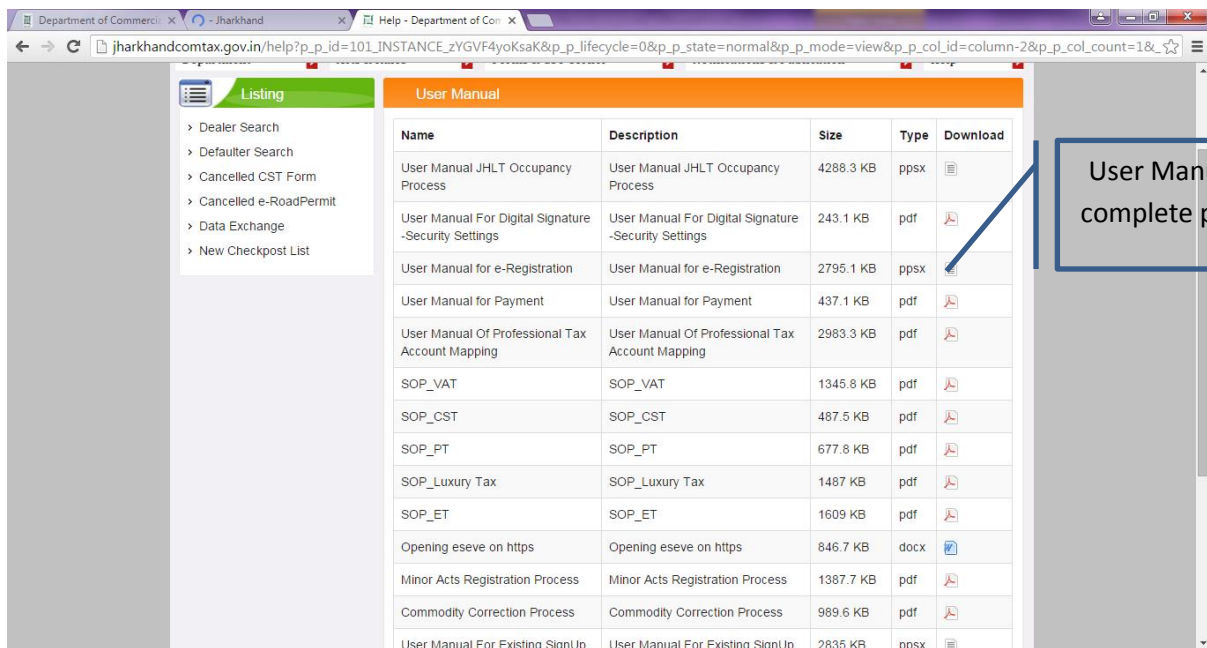

All other Registration Services like Amendment, Cancellation, Registration in CST etc. are not available in V-2 until further announcement.

**e-Return**  
Returns of month September and Previous Periods for VAT Normal and MRP Dealers will be filled in the V-2 on the current Return Formats. Similarly VAT 211 for Composite Dealers and CST Form I for CST Dealers will be filled in the V-2 on the current Return Formats. New Return Formats will be available from November 1st 2014.

**e-Registration**  
Two way Integrated Payment Facility is available with NDML Payment Gateway (as in V-1), State Bank of India and Indian Overseas Bank. Offline Payment will be allowed only till 20th of October 2014.

**e-Road Permit & e-CST Forms**  
All the Sugam (P.B.G), Central Forms (C.F.H.E) and Transit pass are available in the V-2 in Web Forms and ODS. For ODS dealer can download the Template, fill it offline and Upload it.
