

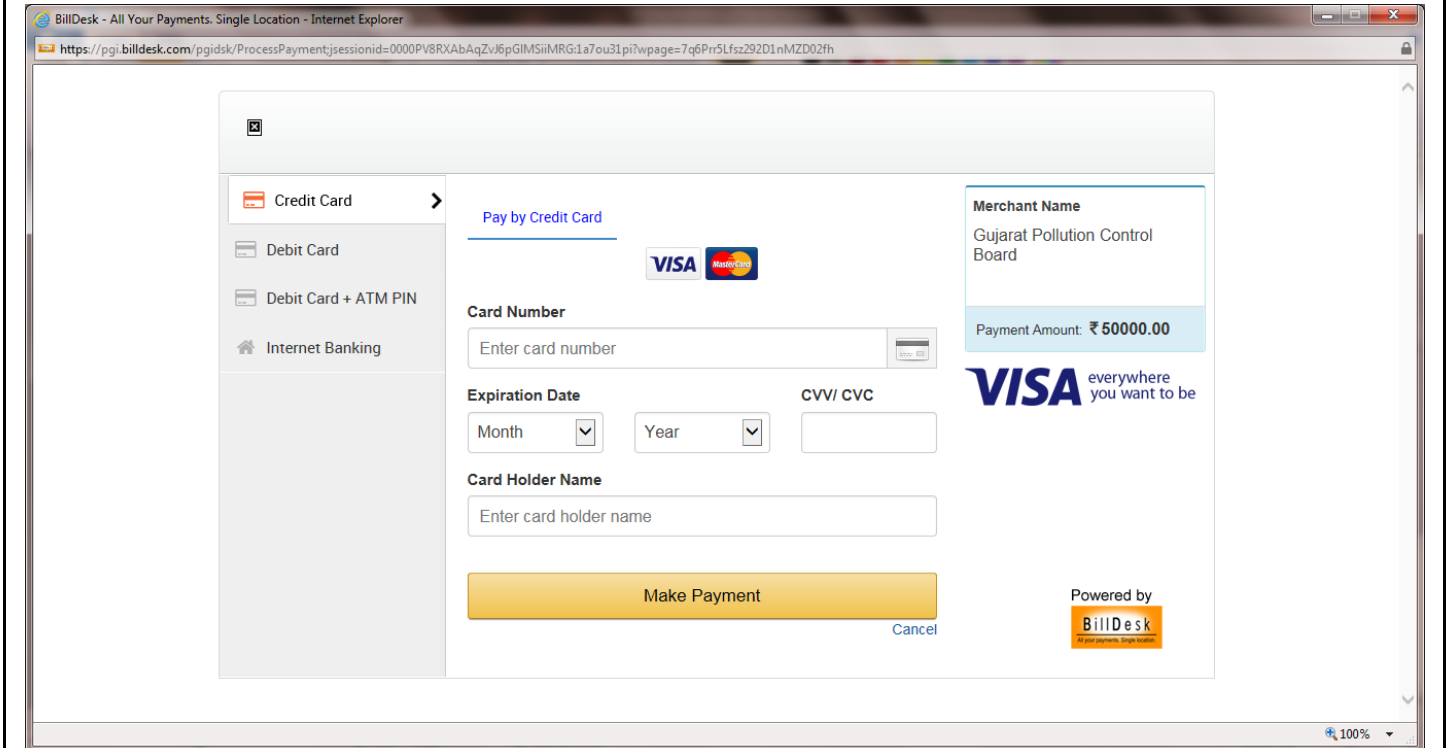

4.2 The applicant shall install & operate air pollution control system in order to achieve norms prescribed below.

4.2.1 The flue gas emission through stack shall conform to the following standards:


