Remarks:

Government of Maharashtra institutionalised Maharashtra industry trade and investment facilitation cell - '**MAITRI**' on 27th February 2014 under the aegis of Industries Department. Situated at Ballard Estate - Mumbai, MAITRI is the dedicated physical body that functions as a one stop solution for all investment & Industry related information and services.

Investor can obtain information regarding all State approvals applicable to establishing his business and start operations on MAITRI. Additionally comprehensive checklist for all required pre-establishment and pre operation NOCs/approvals has been developed on MAITRI. Currently investor can apply for close to 19 services through MAITRI Single Window by filling a Common application form which is easily accessible on MAITRI website (https://maitri.mahaonline.gov.in/)

Below is the step by step procedure to apply for services through MAITRI Single Window:

- 1. User/ Investor needs to create a User Log-In using his basic details and an autogenerated OTP (using his mobile phone)
- 2. After successful registration, he is transferred to the MAITRI, where he can see the Dashboard and the CAF
- 3. Clicking on CAF tab, the user lands on Industry Information page, where he is required to fill in the details related to his Industry like Address of the registered office, investments, requirements, etc.
- 4. On uploading the required document proofs and submission, the user gets a success message prompt which also redirects him to the online payment link
- 5. The user can select the payment gateway from a range of options (Netbanking, IMPS, Debit/ Credit Card) and prominent banks
- 6. Once the payment is successful, the user gets redirected to the dashboard of MAITRI, where he can see details like his CAF application ID, payment and status.
- 7. He also gets access to the comprehensive list of services to which he can apply through his MAITRI details
- 8. On Applying for any of these services, the user can track the status of the application from MAITRI and doesn't have to go to the Department website each time.

2. The user needs to register himself on MAITRI in order to log in on the single window portal.
