No. SPC 1316/133/C.R.14/IX : In exercise of the powers conferred by sub-sections (1) and (3) of the section 3 of the Commercial Courts, Commercial Division And Commercial Appellate Division of High Courts Act, (Act No. IV of 2015), the Government of Maharashtra, in consultation with the High Court of Judicature at Bombay, hereby,-

a) **constitutes a Commercial Court in each District, at sadar station,** excluding the territory over which the High Court exercises ordinary original civil jurisdiction, for the purpose of exercising the jurisdiction and powers conferred on those Courts under the said Act, and

b) **appoints the District Judge-1 posted at the sadar station in each District to be the Judge of the Commercial Court constituted for the said District, and in the District where there is no other District Judge, posted at the sadar station, the Principal District Judge of such District shall be the Judge of the Commercial Court constituted for the said District.**
