Under section 4 of the Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts Act, 2015, the authority to constitute Commercial Division and Appellate Bench in the High Court vests with the High Court.

The High Court has vide notification dated 1st June 2016 constituted the Commercial Appellate Division in the High Court of Gujarat to deal with appeal(s) from orders/ judgement(s) passed by the Commercial Courts or Commercial Divisions. The Divisional Bench has become functional on 6th June 2016 vide High Court's. List of sitting published on 31st May 2016. The High Court has also vide notification dated 1st June 2016 constituted commercial bench to hear commercial disputes.
