Approach to Reform	Government of Telangana has introduced the provision of self-certification for felling exempted trees. If any owner desires to fell a tree, that is exempted, the owner shall only make self-certification to the Divisional Forest Officer, in the Format prescribed with a fee per tree as indicated and proceed to fell the tree. The self-certification application and fees can be made online itself.

In exercise of the powers conferred by sub-section (1) of section 45 of the Telangana Water, Land and Trees Act, 2002 (Act No.10 of 2002), the Government of Telangana hereby makes the following amendments to the Telangana Water, Land and Trees Rules, 2004 issued in G.O.Ms.No.339, Panchayat Raj and Rural Development (RD-IV) Department, dated 06.11.2004 as subsequently amended from time to time, which were adapted to the State of Telangana vide G.O.Ms.No. 18, Panchayat Raj and Rural Development (RD.II) Department, dated.31-01-2015

AMENDMENTS

In the said rules;

for clause (4) of rule 24, the following shall be substituted, namely:

(4) If any owner desires to fell a tree, that is exempted, the owner shall only make self certification to the Divisional Forest Officer, in the Format prescribed in rules as Form 13(A) with a fee per tree as indicated below and proceed to fell the tree.



ORDER

Government after careful examination of the proposal of Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad in the letter 2nd read above, hereby issue the following amendment to Appendix in G.O.Ms.No.19, EFS&T (For.I) Department Dated: 13-05-2016:-

AMENDEMENT

5. The applicant shall enclose the list of trees existing in the proposed land and trees proposed to be felled in Annexure-II in TS-iPASS Common Application Form. If the tree growth proposed to be felled is exempted under WALTA Act/Rule, Self-Certificate to this effect in Form-13A prescribed under WALTA 2002 will be sufficient and no further permission for felling of such trees will be required. At present Eucalyptus, Subabool and Casuarina species are exempted from tree felling permission under WALTA/Rules. For trees other than Eucalyptus, Subabool and Casuarina, the details have to be furnished by the applicant under Form-13 prescribed under WALTA/Rules and enumeration list of trees to be felled has to be furnished in species under WALTA 2002, Application has to be given in Form-13. For tree species not exempted under WALTA 2002, prior felling permission from Divisional Forest Officer/Designated Officer required and if such trees are felled without prior permission, the same will tantamount to an offence and the offender will be liable to be punished under provisions of WALTA Act/Rules and Telangana (Forest Produce) Transit Rules/Telangana Forest Act.

5. The applicant shall enclose the list of trees existing in the proposed land and trees proposed to be felled in Annexure-II in TS-IPASS Common Application Form. If the tree growth proposed to be felled is exempted under WALTA Act/Rule or exempted as per Schedule-II of Telangana Forest Produce (Transit) Rules, 1970, Self-Certificate to this effect in Form-13A prescribed under WALTA 2002 will be sufficient and no further permission for felling and transport of such trees will be required. At present Eucalyptus, Subabool and Casuarina species are exempted from tree felling permission under WALTA/Rules. For trees other than Eucalyptus, Subabool and Casuarina, and those exempted as per Schedule-II of Telangana Forest Produce (Transit) Annexure-II. If proposed trees include Rules, 1970 the details have to be furnished both exempted and non-exempted tree by the applicant under Form-13 prescribed under WALTA/Rules and enumeration list of trees to be felled has to be furnished in Annexure-II. If proposed trees include both exempted and non-exempted tree species under WALTA 2002 or Telangana Forest Produce (Transit) Rules, 1970, application has to be given in Form-13. For tree species neither exempted under WALTA 2002 nor Telangana Forest Produce (Transit) Rules, 1970, prior felling permission from Divisional Forest Officer/Designated Officer is required and if such trees are felled without prior permission, the same will tantamount to an offence and the offender will be liable to be punished under provisions of WALTA Act/Rules and Telangana (Forest Produce) Transit Rules/Telangana Forest Act.

- The Applicant shall submit online "Certificate of Ownership of Tree/Forest Produce" proposed to be felled from the concerned Tahsildar in the Annexure-IV required under Rule 5(3) of Telangana Forest Produce (Transit) Rules, 1970, while applying for tree felling permission under TS-IPASS Common Application Form. Certificate of Ownership of Tree/Forest Produce from Tahsildar is not required, if proposed trees are exempted under WALTA 2002. On successful filing of online application along with regulired certificate/enclosures on TS-iPASS, an SMS alert will be sent to the concerned Forest Officer and Divisional simultaneously to the applicant as well.
- The Applicant shall submit online "Certificate of Ownership of Tree/Forest Produce" proposed to be felled from the concerned Tahsildar in the Annexure-IV required under Rule 5(3) of Telangana Forest Produce (Transit) Rules, 1970, while applying for tree felling permission under IPASS Common Application Form. Certificate of Ownership of Tree/Forest Produce from Tahsildar is not required, if proposed trees are exempted under WALTA 2002 or those exempted as per Schedule-II of Telangana Forest Produce (Transit) Rules, 1970. On successful filing of online application along with required certificate / enclosures on TS-IPASS, an SMS alert will be sent to the concerned Divisional Forest Officer and simultaneously to the applicant as well.

AMENDMENTS

In the said rules;

- (1) for clause (4) of rule 24, the following shall be substituted, namely:-
- (4) If any owner desires to fell a tree, that is exempted, the owner shall only make self-certification to the Divisional Forest Officer, in the Format prescribed in rules as Form 13(A) with a fee per tree as indicated below and proceed to fell the tree.
 - (I) For urban residential and institutional areas Rs.50/-(II) For urban commercial areas Rs. 100/-*
- (2) after clause (4) of rule 24, the following sub-clause shall be added, namely:-

(4)(a) If any owner desires to fell a tree, that is not exempted from obtaining transit permit under Andhra Pradesh Forest Produce Transit Rule, the owner shall inform to the Divisional Forest Officer in the Form 13 as prescribed in rules, of the intentions to fell a tree with a fee per tree as indicated below.

> (I) For urban residential and institutional areas Rs.50/-(II) For urban commercial areas Rs. 100/-*

(3) for clause (5) of rule 24, the following shall be substituted, namely:-

"(5) On receipt of such application form, the applicant, the Designated Officer shall complete all necessary pre-requisite action to issue permission for felling within (3) days from the date of submission of application. In case the designated authority does not intimate the final decision on the application, it shall be deemed that the applicant is authorised to fell the tree as requested in his application. In case of applications categorized as high risk, Divisional Forest Officer shall be the designated authority. In other cases, concerned Forest Range Officer shall be the designated authority.

High risk is defined as that involves the following type of trees.

- Teak
- Rose wood
- Red Sanders
- Sandalwood

or that involves felling or more than 20 non exempted trees / per acre. Deemed approval does not bestow any right on the applicant to transport the felled tree. Permission to transport a non-exempted tree is mandatory.

Provided further that, if the tree permitted to be felled is not exempted from purview of Forest Produce Transit rules, the Designated Officer/Owner shall Inform the concerned Divisional Forest Officer for grant of transit permit and the owner shall not transport felled material without a valid permit."

(4) for clause (8) of rule 24, the following shall be substituted, namely:-

(6) The Designated Officer shall dispose the application within three days from the date of receipt of application by the owner / applicant."

(5) for clause (1) of rule 26, the following shall be substituted, namely:-

"(1) Whoever contravenes/violates any of the provisions of this act shall be punishable with fine which shall not be less than Rs.1000/- but which may extend to Rs.5000/-."

(6) for clause (2) of rule 26, the following shall be substituted, namely:-

(2) For felling of non-exempted and prohibited trees without prior permission, whether deemed or issued shall be punishable with a fine which shall not be less than two times the value of such tree, but which may extend upto 5 times of the value of such tree."
