Approach to Reform	In the dedicated online system Sahayoga developed by the Department of Labour, options are available where the establishments (users) can log into the portal to view and download the inspection report as submitted by the Inspector with reference to their establishment.

Step 1: Enter the url-karlabour.in/sahayoga on the web browser Home page

Click on the 'establishment' tab in the side bar where you will get multiple sub menus(as shown and mentioned below)

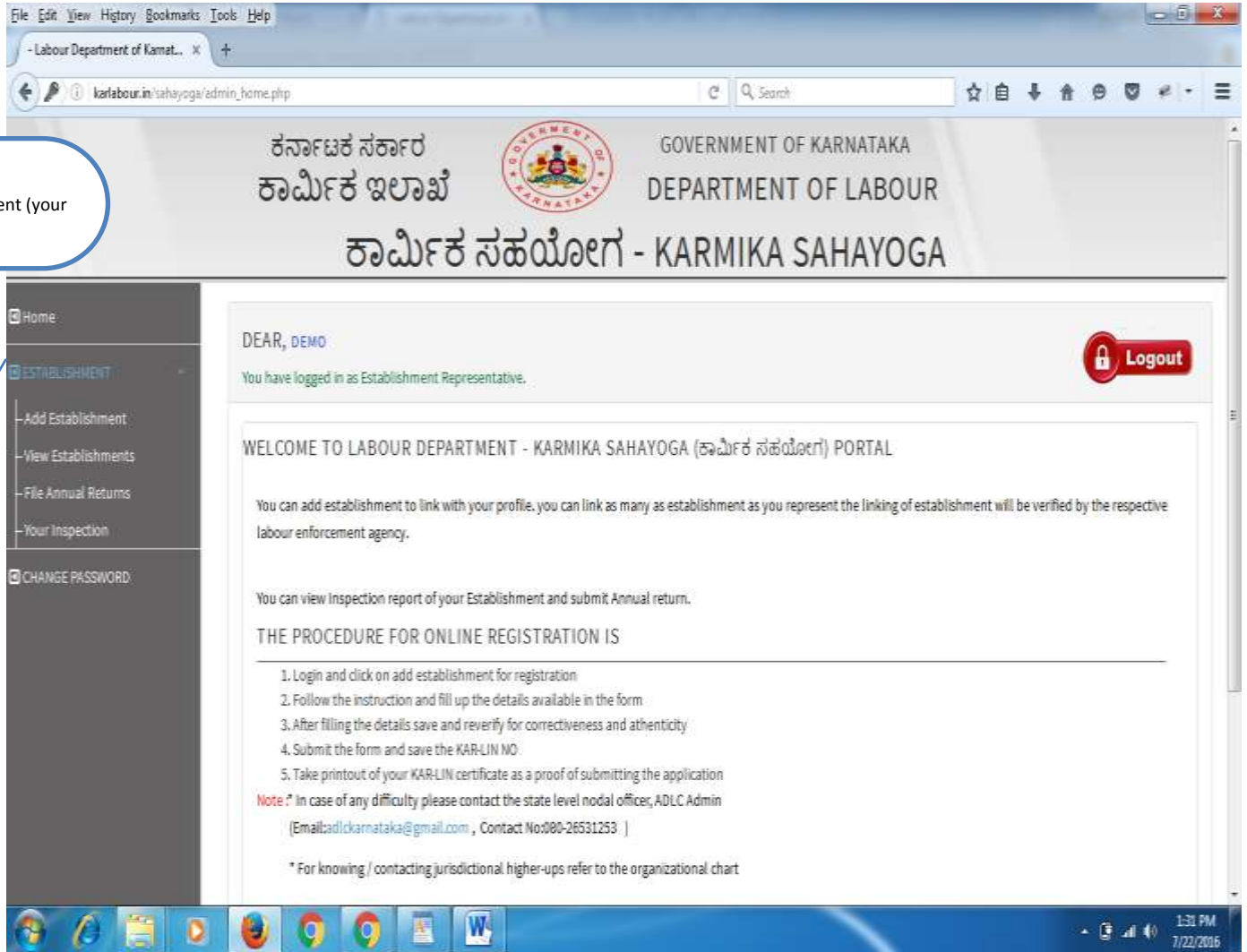

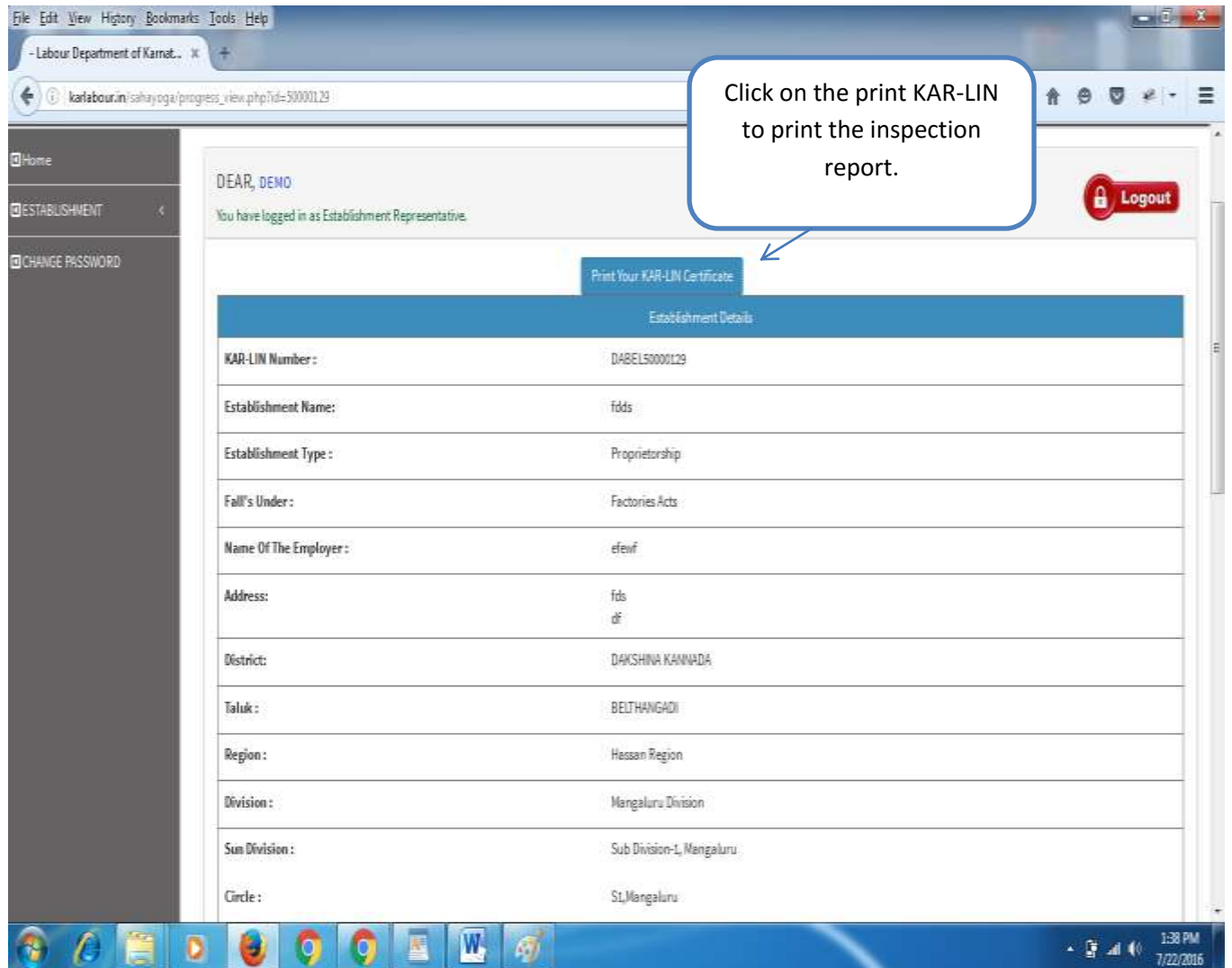
