Photographs of parties to the document are captured by web-camera and thumb impressions are taken by bio-metric device at Sub-Registrar offices. In the Electronic Registration System - “SAMPADA”, facilities such as - valuation of property situated anywhere in the State, calculation of stamp duty and registration fee chargeable on different types of documents and slot booking in the office of the Sub-Registrars are available.
