The State Board vide notification No. PCB (Engg) Bd. Mtg. (44)/99-5511-5541 dated 25-08-2000 had adopted the Schedule for regulating the inspection and sampling of industries. As the aforesaid Schedule is based only on the consideration of the potential of pollution in a particular industry in a specified category and does not integrate the magnitude aspect of pollution potential. Therefore, in order to make the Schedule more objective by integrating the magnitude aspect of pollution potential, the Schedule notified earlier is superseded as per decision taken by the State Board in its 46th meeting held on 20-11-2001 vide Item No. 46.17 by the following Schedule:
