Dhar (M. P.) total area (38.538 Hact Govt land +97.709Hact private land) with capacity 0.8 MTPA,
SUBJECT TO THE FOLLOWING CONDITIONS :-

a. Location :- Villages; Karondiya, Badiya, Ghursal & chakdood District. Dhar (M. P.)
(38.538 Ha Govt land +97.709Ha pvt land)

b. Production:-

Product	Capacity
Mining of Lime Stone	0.80 million TPA (ROM) (Zero Point Eight Zero Million Tonnes per Annum)

The consent (for operation) as required under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 shall be granted to your industry after fulfillment of all the conditions mentioned above.
